MILL STREET ROADWAY IMPROVEMENTS

DECEMBER 5, 2017

Sealed Bids for the construction of the **Mill Street Roadway Improvements** project will be received, by the **Town of Ware Shoals**, at their office located at **8 Mill Street, Ware Shoals, South Carolina 29692**, until **2:00 PM** local time on **December 21, 2017**, at which time the Bids received will be publicly opened and read.

The Project consists of constructing a new cross section for approximately 400 LF of Mill Street in Ware Shoals, SC. Included is the removal & replacement of approximately 800 LF of 30" curb & gutter with standard 18" curb and gutter, removal and replacement of 440 SY of 4" thick concrete sidewalk as well as 3" milling of the existing asphalt surface to expose the concrete roadway below. The roadway will then be full-depth patched as necessary and overlaid with 75#/SY Type E (60 Tons) and 220#/SY Type C HMA (180 Tons). Various other incidentals are also included such as concrete stairs, driveway aprons, pedestrian ramps, and reconstructing an existing storm drain inlet.

Bidding Documents may be obtained from the Issuing Office during the hours indicated above. Bidding Documents are available via email (as portable document format (PDF) files) for a non-refundable charge of \$25.00. Alternatively, printed Bidding Documents may be obtained from the Issuing Office either via in-person pick-up or via mail, upon Issuing Office's receipt of payment for the Bidding Documents. The non-refundable cost of printed Bidding Documents is \$100.00 per set, payable to "Dunn & Associates Engineering, Inc.". Upon Issuing Office's receipt of payment, printed Bidding Documents will be sent. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the prospective Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda, if any, obtained from sources other than the Issuing Office.

Bid security in the amount of 5% of the bid shall be furnished in accordance with the Instructions to Bidders.

No bid will be considered unless the bidder is legally qualified under the provisions of the South Carolina Contractor's Licensing Law.

Bidders must comply with Executive Order No. 11246 which obligates the Contractors not to discriminate in employment practices.
